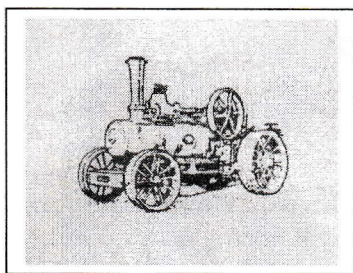

### REMPSTONE STEAM & COUNTRY SHOW 9<sup>th</sup> & 10<sup>th</sup> JULY 2022 <sup>3</sup>

We will be holding our annual Steam & Country Show on the above dates at Turn Post Farm, Wymeswold. You are invited to submit the enclosed entry application form which should be returned by no later than the date indicated on the form. Numbers may be limited so please apply early; late applications may not be successful.

There may be changes to the Show layout again this year so your exhibit area location may change. As in past years, vehicles, caravans or exhibits parked without the Section Steward's direction may be required to move.

Ticket allocation will be made to each exhibit. Please ensure that you complete the form correctly and in full.


**A STAMPED ADDRESSED A5 ENVELOPE MUST BE RETURNED WITH YOUR APPLICATION FORM. In addition if you require confirmation of your entry before passes are sent out, please also enclose a stamped addressed postcard.**

#### INSURANCE

From a safety aspect it will be necessary for all exhibits to be placed in the enclosures provided, and carry appropriate insurance, including £5 million public liability.

The showground falls under the Road Traffic Act and all movement of vehicles upon the showground should be carried out in accordance with said act. Anyone not complying with these stated conditions will be removed from site without question. The ONLY exception to this condition is for steam vehicles where members of the Steam Apprentice Club may drive subject to ALL the terms in the NTET Code of Practice being met. Persons under 16 years of age are not permitted to be left in charge of machines or mechanically propelled vehicles.

Passengers may only be carried when properly constructed seats are fitted.

 You will be required to produce your insurance documents on arrival at the rally site. Where appropriate NTET discs **MUST** be displayed.

**In the event of any dispute, the show organiser's decision will be final.**

## **Schedule of General Conditions applying during the occupation of the site. (For Exhibitor read Exhibitor/Trader)**

1. The Club reserves the right at all times to refuse admission to any Exhibitor or his/her staff.
2. All admission of Exhibitors and their staff will be by special pass issued by the Club and Valid for the Rally days only. Additional passes may be available, on request, at the discretion of the Section Steward.
3. Acceptance by the Club of a firm booking in no way confers any rights whatsoever to the Exhibitor and in no way modifies these Conditions.
4. **The showground falls under the Road Traffic Act and all movement of vehicles upon the showground should be carried out in accordance with said act. Anyone not complying with these stated conditions will be removed from site without question.**  
The ONLY exception to this condition is for steam vehicles where members of the Steam Apprentice Club may drive subject to ALL the terms in the NTET Code of Practice being met.
5. The site must be left in a clean and tidy condition. Please take your waste home with you.
6. All Exhibitors and their personnel must follow the instructions issued by the Club or their delegated representatives. In all matters of Health and Safety the authority of the Safety Officer (Matt Chivers) is paramount and overrides all others.
7. In all matters of dispute the Club's decision will be final.
8. All Exhibitors will be responsible for their public liability insurance and will absolve the Club from any such legal liability.
9. Exhibits must be as described on the booking form.
10. The use of PA systems is only allowed if authorised by a member of the committee.
11. All dogs must be kept on a leash at all times and be under proper control.
12. Open fires are not permitted and BBQs must be sufficiently off the ground to prevent damage. The organizers retain the right to ban the use of BBQs or similar if the ground conditions are unsuitable in their opinion.
13. The allocation of sites, positioning of Exhibitor space and the allocation of passes will be at the discretion of the Section Steward, although every endeavour will be made to meet any reasonable request made by an Exhibitor, which does not impact unfavourably on others.
  - (a) Exhibitors booking open space must apply for sufficient space for all stays or guy ropes required for any building, tent or caravan to be erected on the space.
  - (b) Boundaries of sites will be allocated by the Section Steward and in no circumstances will Exhibitors be allowed to occupy a larger space than that allocated to them.
  - (c) The Club will not be held responsible for damage caused to sites/displays and will not undertake to make good such damage.
  - (d) Exhibitors must confine their activities to the area of their stand and must not use the avenues.
14. All electrical generators, wiring and appliances used in the presence of the public should have a current certificate in accordance with the I.E.E. regulations and these may be inspected by the Club's Safety Officer, who has the authority to prohibit the use of unsafe electrical generators, wiring and appliances.
15. The use of drones is **NOT** allowed on the Public Caravan and Camping site, Show fields, Exhibitor Camping fields, or Car Park at any time, except with the written permission of the organisers.
16. Pitches must be cleared of debris at the end of the show.

## **SPECIFIC CONDITIONS OF ENTRY (must be returned with entry form)**

Exhibits must be booked in with the Section Steward **on arrival** on the showground and insurance details must be produced at this time. **I will provide correct entry details and documentation which relates to the entry as described.**

**But for exceptional circumstances, low loaders are not allowed on the showground and must be parked in the Low Loader Park, all unloading/loading to take place in the Low Loader Park.**

**Caravans, tents, vehicles and trailers may not be allowed in the section on the showground but may be placed in an exhibitor camping area set aside for them at the direction of the Section Steward.**

**YOU WILL BE MOVED IF YOU PARK IN THE WRONG PLACE CHECK WITH YOUR SECTION STEWARD**

All exhibitors are expected to attend for both full show days, unless otherwise agreed, and exhibits **MUST** be on display from 10.00 a.m. until 5.30 p.m. on Saturday and from 10.00 a.m. until 5.00 p.m. on Sunday. No exhibit will be allowed to leave early on either day, except with the express permission of their Section Steward.

Exhibitors must be available at their exhibits as required by the Section Steward.

**ALL EXHIBITORS MUST SIGN THE FOLLOWING DECLARATION OR THE ENTRY CANNOT BE ACCEPTED.**

### **INSURANCE**

I declare that during the whole of the show period my entry will be covered by a Public Liability Policy including 'Rally use' having a limit of indemnity of not less than £5,000,000 in respect of any one accident. I further declare that the use of the vehicle hereby entered is covered by insurance as required by the Motor Vehicles (Off Road Events) Regulations 1992, which is valid for such part of this event as shall take place on roads as defined in the Act. I confirm that the driver/s of any vehicle entered holds and is not disqualified from holding or obtaining a licence to drive a vehicle of the appropriate class.

### **DRIVING and SUPERVISION OF EXHIBITS**

The showground falls under the Road Traffic Act and all movement of vehicles upon the showground should be carried out in accordance with said act. Anyone not complying with these stated conditions will be removed from site without question. The **ONLY** exception to this condition is for steam vehicles where members of the Steam Apprentice Club may drive subject to **ALL** the terms in the NTET Code of Practice being met. RTEC will not share your data with any third party or contact you other than in reference to the show. The published programmes will only show details of the exhibit and the exhibitors name not addresses or contact details, please indicate if this is **NOT** acceptable by filling in the appropriate section on the application form.

**Exhibitors will not be allowed onto the Site before 12 noon on the Thursday preceding the Show.  
If this presents a problem please contact your section steward.**
